Proposition:

Shall the district be authorized to impose an increase in local taxes to support the Elementary General Fund in the amount of Three Hundred Eleven Thousand Two Hundred Twenty-Four and 11/100 dollars (\$311,224.11) which is approximately Three and Seventy-Three Hundredths Mills (3.73) to meet the normal operational costs of the Elementary District General Fund for the 2018-2019 fiscal year? The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount at least once in the next five years. Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$5.04 and on a home with a market value of \$200,000 by approximately \$10.07.

Shall the district be authorized to impose an increase in local taxes to support the High School General Fund in the amount of Two Hundred Six Thousand, Three Hundred Eighty-Five and 73/100 dollars (\$206,385.73) which is approximately Two and Forty-Seven Hundredths Mills (2.47) to meet the normal operational costs of the High School District General Fund for the 2018-2019 fiscal year? The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount at least once in the next five years. Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$3.33, and on a home with a market value of \$200,000 by approximately \$6.67.
